Paso 1: Acceda a la página principal de MSS en: <https://member.unjspf.org/>

Paso 2: Inicie una sesión en MSS.

Paso 3: Haga clic en “Restore”.

Restoration

Restoration of most recent prior contributory service (Article 24 of the UNJSPF Regulations and Section F of the UNJSPF Administrative Rules)

Restoration under Article 24 is optional and applies to former UNJSPF participants who previously separated, received a Withdrawal Settlement, and wish to restore their most recent prior contributory service by reimbursing the Fund (with interest).

To be considered, the Fund must receive your expression of interest:

- within one (1) year of the start or restart of your participation in the Fund, or
- before your separation from service, whichever comes first. Requests submitted after this period cannot be accepted.

Before submitting, please ensure that you are within the 12-month eligibility window.

How to submit a Restoration request

The start and end dates of the period to be restored appear automatically. Click Submit to proceed. Once submitted your request cannot be modified.

Your request will be reviewed by the responsible pension office, which will confirm eligibility and contact you if needed.
