It may also be possible to restore prior contributory service, if any, under article 24 of the UNJSPF Regulations, provided that you apply within one year of your date of entry or re-entry into the Fund, but before separation should you separate from service earlier. You may also avail yourself of the provisions of any transfer agreement entered into by the Fund for the purpose of securing the continuity of pension rights under article 13 of the UNJSPF Regulations, in accordance with the terms of the relevant agreement.
